## Commitment to achieving Net Zero

Sentinel Partners Limited is committed to achieving Net Zero emissions by 2035.

## Baseline Emissions Footprint

### Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 25.0tCO<sub>2</sub>e by 2029. This is a reduction of 12.6% which whilst not a huge number is continual progress after a drop of 65% since 2021.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 53.8tCO<sub>2</sub>e, a 65%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract

- Moved to more efficient offices.
- Increase in work from home.
- Car sharing when staff come into the office.
- Continued use of Teams, removing the use of mobile telephones and the need to travel as frequently.

### Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
